NOTICE OF TORT CLAIM

Comes now, Sandra Hurd, and for her Notice of Tort Claim against Tracey Shorter, in her individual capacity, and against Tracey Shorter, Larry Brady, and Terry Young, Pulaski County Commissioners, Sheila Garling, Pulaski County Auditor, and Kevin Tankersley, Pulaski County Attorney, in their official capacities, and pursuant to Ind. Code §34-13-3-1 et seq., says:

- 1. That at the time of the filing of this verified Notice of Tort Claim Sandra Hurd resides at 422 N. Monticello St., Winamac, Pulaski County, Indiana; at the time of all relevant occurrences herein, she resided at the same address;
- 2. That at all relevant times herein, up until August 27, 2013, Sandra Hurd was serving as the County Home Superintendent for Pulaski County, a position she had held for five (5) years and had been reappointed to on January 1, 2013;

3. That around or about the beginning of July 2013, Sandra Hurd discovered that

she may be making a clerical error in reporting information to a state agency;

That around or about the beginning of July 2013, Sandra Hurd contacted the

state agency to learn the process of correcting her clerical error;

That on or about July 24, 2013, Commissioner Tracy Shorter became aware of

this clerical error and investigated whether Sandra Hurd was committing fraud;

That on or about July 30, 2013, Sandra Hurd filed paperwork with the state

agency to self-report her clerical error and to fix her error;

That if the state agency discovered Sandra Hurd's error before she self-

reported, she would have been personally liable and/or fined by the state agency for not self-

reporting her clerical error;

That on or about August 15, 2013, Sandra Hurd was suspended from her job

with pay for a period of ten days;

That on or about August 15, 2013, Commissioner Tracy Shorter appointed

herself interim Superintendent of the County Home:

10. That on or about August 15, 2013, Commissioner Tracy Shorter made

assurances to Sandra Hurd and the employees of the County Home that Sandra would be reinstated

after a ten day suspension, if she only committed a clerical error;

11. That on or about August 22, 2013, Commissioner Terry Young received a letter

from the state agency confirming that Sandra Hurd did not commit fraud; it was just a clerical error;

12. That Commissioner Tracy Shorter was aware of the fact that Sandra Hurd only

committed a clerical error and did not in fact commit fraud:

13. That the Pulaski County Commissioners employed the firm of Waggoner,

Irwin, Scheele & Associates to investigate certain allegations and accusations, and Paula Reimers

of that firm conducted the investigation;

14. That the investigation consisted of Paula Reimers questioning of current and

former County Home employees on or about August 15, 2013, including Sandra Hurd;

15. That at the meeting on or about August 27, 2013. Sandra Hurd was discharged

from her duties as Superintendent for the County Home;

16. That Kevin Tankersley told Sandra Hurd she was not entitled to an appeal of

Tracey Shorter's decision;

17. That it is clear from the manner in which the entire situation was handled that

Tracey Shorter, Larry Brady, Terry Young, Sheila Garling, and Kevin Tankersley conspired

together to damage the reputation and name of Sandra Hurd by leaving a cloud of suspicion with

the public as to what acts or misdeeds may or may not have been committed by Sandra Hurd to

suspension and termination by suggesting criminal conduct;

18. That Tracey Shorter, Larry Brady, Terry Young, Sheila Garling, and Kevin

Tankersley acted jointly and severally, to slander and defame the reputation and character of Sandra

Hurd:

19. That the disciplinary action form completed by the commissioners indicated

that Sandra Hurd was guilty of "intentionally modifying records;" that the form also indicated that

Sandra Hurd's actions were intentional and had been occurring for over a year,

20. That the statements came about in the presence of Paula Reimers, an outside

individual not involved with Pulaski government;

21. That Sandra Hurd was wrongfully discharged when she was terminated for

self-reporting her clerical error to the state agency;

22. That Tracey Shorter, Larry Brady, Terry Young, and Kevin Tankersley, have

further slandered and defamed Sandra Hurd in making statements regarding her honesty, for which

there is no proof whatsoever, and that their actions were intentional;

23. That Commissioner Tracy Shorter contacted the Indiana State Police to falsely

report that Sandra Hurd stole personal property and groceries from the County Home in furtherance

of the conspiracy to wrongfully terminate Sandra Hurd; that the State Police investigation has been

cancelled with no finding of wrongdoing;

24. That the actions of Tracey Shorter, Larry Brady, Terry Young, and Kevin

Tankersley were clearly intended to damage the character and reputation of Sandra Hurd within the

community and the statements were made with reckless disregard of the effect of said statements,

and with no ability to prove the truth of any of said statements:

25. That Tracey Shorter, Larry Brady, Terry Young, Sheila Garling, and Kevin

Tankersley have done nothing to publically correct or repair the erroneous and malicious

impression that their actions created to damage the character and reputation of Sandra Hurd in the

community;

26. That because of the actions of Tracey Shorter, Larry Brady, Terry Young, and

Kevin Tankersley, Sandra Hurd is having, and will continue to have, a difficult time securing

employment in her line of work because of these false and malicious statements;

27. That as a direct result of the actions of Tracey Shorter, Larry Brady, Terry

Young, Sheila Garling, and Kevin Tankersley, Sandra Hurd has been damaged in the sum of

\$500,000.00.
