ORDINANCE NO. 12 OF 2014

AN ORDINANCE AMENDING THE MONTHLY ELECTRIC RATES AND CHARGES FOR THE WINAMAC MUNICIPAL ELECTRIC UTILITY

WHEREAS, the Town of Winamac, through its Municipal Electric Utility, is responsible for the safe and effective operation of an Electric Utility for the welfare of residents of the Town of Winamac, Indiana, and surrounding areas; and,

WHEREAS, the Town of Winamac has caused a financial and cost-of-service study of the Town's municipal electric utility ("Rate Study") to be made by the IMPA Service Corp., Carmel, Indiana; and,

WHEREAS, the Rate Study indicates it is necessary to adjust the rates and charges for monthly usage of electricity that the municipal utility charges its users in order to meet its ongoing revenue requirements of operation, maintenance, replacements, and payment in lieu of taxes; and,

WHEREAS, it has been recommended to the Town Council that the rates be increased to a level that reflects the new costs of electricity to the Electric Utility and still provide the users with good and competent service;

BE IT THEREFORE RESOLVED that the effective rate schedule for the Town of Winamac Municipal Electric Utility is hereby amended as follows:

SECTION VIII

Terms of Payment

All bills on the above schedule shall be rendered and due monthly. If not paid by the fifteenth (15th) day of the month following the date of the bill, there shall be added a three percent (3%) penalty to the amount of the bill.

Non-Payment of Bills

Whenever the service is disconnected for non-payment of bill, or whenever for any reason beyond the control of the utility a reconnection of service is required by any customer more often than once in a twelve-month period, a charge of \$25.00 shall be assessed.
