VENDOR REGISTRATION FORM

Crafters, artisans and vendors are invited to set up booths to sell their merchandise or promote their business. Booth space is approximately 8 ft wide x 10 ft deep. (accommodates two 8ft tables or three 6 ft tables)

Vendor fees are \$40 for non-food items and \$60 for food sales. This fee is for all 3 days of the festival. Your spot is not reserved until this registration form and payment is made. Please make your checks payable to **TORCHFEST**. Entry deadline is September 30, 2016. Due to the size of this festival we must enforce this deadline!

<u>PLEASE NOTE</u>: It is not required that you have a booth at the festival all 3 days however, it is strongly encouraged. The booth price is the same regardless of how many days you have a booth at the festival.

Vendors are responsible for the following:

- * Tables, chairs, electrical cords (if required), and other supplies as needed.
- * Liability insurance for your booth, including public liability
- * Overnight security of your merchandise and promotional items on Friday and Saturday evening. Food Vendors are also required to:
- * Follow all Federal, State and Local fire codes and Health Dept codes, including inspected equipment and a food permit from the Pulaski County Health Dept. <u>If you have questions or need additional information</u> please contact the Pulaski County Health Dept at 574-946-6080
